IEA-NEA Region 6





This summer I, along with 14 other Region 6 delegates, attended the National Education
Association Representative
Assembly in Philadelphia. We got through our first caucus, our second caucus/first day of the RA

(which was amazing), and our third caucus. As we were headed to vote in the convention center for constitutional amendments, bylaw amendments, and candidates for NEA Executive Committee and NEA At-Large Directors hundreds of phones started pinging and going off. At first we were not sure why, I thought it was some sort of national emergency or amber alert, but it was not. The National Education Association Staff Organization approved a three day strike in the middle of the RA. This labor action shut down the RA on day two. All business was sent to the NEA Board of Directors and ballots were mailed to delegates to vote on the constitutional and bylaw amendments and candidates. Side Note: we had one person from Illinois, Amy Evans, get elected to the NEA Board of Directors. It was very exciting when they announced the results. Eventually, NEA and NEASO resolved the strike in August and now back to work.

However, this strike action did cause some major issues but the number one issue is that the NEA Fund took a huge hit. The NEA Fund is a VOLUNTARY donation members can give to NEA to support pro-public education candidates federally. Many delegates wait until the 2nd, 3rd, or even the last day of the RA to donate. They like to "stockpile" their donations to the last day to win the state affiliate prizes. This strike action on day 2

caused the NEA Fund donations to be hundreds of thousands of dollars in a shortfall compared to past years. The reason this is very concerning is that this is an important election in November to protect our public schools and public school students. Why? Do you remember the name Betsy DeVoss who was appointed by former President Trump? She, as the United States Secretary of Education, single handedly tried to ruin public schools and divert important money and resources from public to private schools. This is a disservice to our students.

The NEA Fund is our voice in Washington and it speaks on behalf of our 3 million members. As the NEA's national PAC, the NEA Fund supports pro-public education candidates. Every member who contributes to the NEA Fund does so voluntarily. Every dollar contributed to a candidate, a political party, or independent expenditures is voluntarily given. NEA does not use dues dollars for this purpose. But, once again, the largest fundraiser for the NEA Fund is during the NEA RA from the 5000+ delegates.
